### MINOR EXEMPTION FOR LOT 5162678 AND LOT 5162680, 292 Route 105 - 1.1

#### **Correction 2022-06-156**

« WHEREAS the owners of 292 Route 105 have applied for a minor variance in order to build;

WHEREAS the property that is the subject of the minor variance claim does not enjoy any rights acquired as a result of the demolition of the existing buildings in the summer of 2021;

WHEREAS the request for a minor variance is admissible under section 10 of Regulation 04-2019;

WHEREAS the project under consideration as a whole falls within the parameters of minor derogation;

WHEREAS only part of the property is in an agricultural area and the front margins are different in the urban area compared to other areas;

WHEREAS all the steps for approval with the CPTAQ and for the addition of use in the area concerned have been successfully completed;

WHEREAS the application seeks to authorize the construction of the building 6m from the front lot line when the zoning by-law section 6.2.1.2 mentions that the non-urban area must be 9 metres:

WHEREAS the publication of the minor variance states that the application is intended to authorize the encroachment of the eaves at 4.34m from the front lot line on the left side and 4.31m from the right side our by-law applies only to the walls of the building;

WHEREAS the application seeks to authorize the visual encroachment of the construction at 16.93m of the public utility corridor of the MRC de la Vallée-de-la-Gatineau (Bike Path) instead of the 35m. and that the very nature of the building is for the users of the trail as well; in addition to the fact that the manager of the two entities is the same, the MRCVG;

WHEREAS the application seeks to authorize the encroachment of the construction at 4.22m from the rear lot line instead of 5m.il is noted that the vessel respects setbacks and complies with section 6.2.1.4 of the regulation;

WHEREAS the application has been transferred by the director of the planning department to the members of the CCU, for study of the file and to make a recommendation to the municipal council;

WHEREAS the Planning Advisory Committee has taken note of all the documents provided by the applicant and has made the overall study; »

**WHEREAS** the request for a minor variance positively meets the following nine (9) criteria inclusively:

- 1. It must be consistent with the objectives of the master plan;
- 2. It must cause serious harm to the person requesting it;
- 3. It shall not affect the enjoyment by the owners of neighbouring immovable property of their right to property;
- 4. It shall not have the effect of aggravating risks to public safety;
- 5. It shall not have the effect of aggravating public health risks;
- 6. It must not adversely affect the quality of the environment;
- 7. It must not prejudice the general welfare;
- 8. It must be of a minor nature;
- 9. If the work is in progress or already carried out (and the work has been the subject of a building permit), the work must have been carried out in good faith.

**WHEREAS** for the above reasons, the CCU recommends that City Council **grant** the minor variance for 292 Route 105

**WHEREAS** the CCU recommends delimiting the space reserved for the entrance to the parking lot and the exit in order to secure the remaining space in order to prevent access to motorized vehicles.

- 9.1 Property taxes, rates for municipal services, special taxes and compensation from the Municipality are included in the tax bill as of the 2022 taxation year.
- 9.2 The debtor and co-debtors are subject to the payment of taxes due to the Municipality of the Township of Low. For the purposes of this by-law, the debtor is defined as being the owner within the meaning of the Act respecting municipal

taxation in whose name a unit of assessment is entered on the property assessment roll or, in the case of immovables covered by the Act respecting municipal taxation, the person required to pay the property taxes imposed on this immovable or the amount in lieu thereof.

9.3 Property taxes must be paid in one lump sum. However, when the total of property taxes, rates and compensation from the Municipality is equal to or greater than \$300, these may be paid, at the debtor's choice, in a single payment or in four installments:

1st installment: April 20, 2022
2nd installment: June 22, 2022
3rd installment: September 21, 2022
4th installment: November 23, 2022

- 9.4 When a payment is not made within the stipulated time, the entire balance of the account then becomes immediately due.
- 9.5. The unpaid balances of municipal taxes, rates and compensations and compensations for municipal services bear interest at the annual rate of 15% from the time they become due.
- 9.6. A penalty of 0.5% of the unpaid principal per full month of delay, up to 5% per year, is added to the amount of taxes payable.

#### **Article 10 - Provisions applicable to all sections**

- 10.1 An administration fee in the amount of \$25 will be charged to the drawer of a cheque or other order of payment when the cheque or order of payment given to the Municipality is refused by the drawer.
- 10.2 At the time of making an update to the assessment roll, where the total of the supplementary invoice is less than \$5.00, there will be no billing or refund on that file.
- 10.3 Refunds due to overpayments shall be issued after an analysis of credit balances and at the request of the owner. The fee for issuing an overpayment refund cheque is \$10 per cheque issued.

#### **Article 11 - Miscellaneous Provisions**

- 11.1 The taxes mentioned in the present by-law do not have the effect of restricting the levying or imposition of any other taxes provided for or decreed by any other municipal by-law.
- 11.2 The present by-law replaces the previous by-laws relating to tax rates and rates or compensation.
- 11.3 Council enacts this by-law as a whole and also paragraph by paragraph and section by section, so that if any paragraph or section should be declared invalid, the remaining provisions of the by-law shall continue to apply.
