REQUEST TO THE QUÉBEC MUNICIPALE COMMISSION / INTERMUNICIPAL AGREEMENT RELATING TO GARBAGE AND RECYCLING REMOVAL - 9

WHEREAS the intermunicipal agreement relating to garbage removal and recycling entered into between the Municipality of Denholm and the Municipality of the Township of Low on December 6, 2016.

WHEREAS this agreement is for a period of five (5) years from its signature, which therefore expires on December 6, 2021, but is automatically renewable for successive periods of two (2) years unless one of the municipalities notifies the other municipality of its intention to terminate it.

WHEREAS this agreement provides for the formation of an intermunicipal committee whose mandate is, in particular, to study any question relating to the subject of this agreement, to submit to the council of each municipality party to the agreement any recommendation deemed useful and monitor compliance with the commitments of each of the municipalities that are parties to the agreement.

WHEREAS no meeting of the intermunicipal committee has taken place in recent years regarding the application of said agreement.

WHEREAS despite several verbal and written attempts by the representatives of the Municipality of the Township of Low to have a meeting of the intermunicipal committee to deal with problems relating to the application of this intermunicipal agreement.

WHEREAS several appeals have been filed since January 28, 2021 to the municipality of Denholm in order to fix a meeting of the intermunicipal committee.

WHEREAS on February 23, 2021, the Director General transmitted to the Director General and the Mayor of the Municipality of Denholm an invitation to a meeting of the intermunicipal committee in order to discuss several subjects concerning the problems of application of the said intermunicipal agreement following a draft agenda sent to the Municipality of Denholm for this purpose, proposing a meeting on March 3, 2021 or failing this asking the Municipality of Denholm to suggest other dates and times for the meeting;

WHEREAS the Mayor of the Municipality of Denholm indicated that he was not available on March 3 for such a meeting and that his Director General would be on vacation for a period of three (3) weeks.

WHEREAS the Municipality of Denholm has been previously informed of several problems related to the application of this agreement which have not yet been resolved as of this day.

WHEREAS resolution AR20-11-133 adopted on November 3, 2020 by the municipal council of the Municipality of Denholm informing the Municipality of the Township of Low that it will terminate the agreement relating to garbage removal and recycling due on December 6, 2021.

WHEREAS it is necessary that the problems of application of the said intermunicipal agreement be resolved as soon as possible, and this, considering the problem concerning the services provided on the territory of the Municipality of the Township of Low, the absence of consent as to the schedule for garbage and recycling removal on the territory of the Municipality of the Township of Low for the year 2021, imposed by the Municipality of Denholm, the absence of annual accountability, the need to carry out a determining the terms of financial adjustments and determining the rules for the sharing of assets and liabilities at the expiration of the said intermunicipal agreement;

WHEREAS the lack of collaboration on the part of the Municipality of Denholm.
