#### # 152-07-2021 SUPPORT FOR THE MARIA-CHAPDELAINE MRC - REQUEST TO DECENTRALIZE QUEBEC'S HEALTH CARE SYSTEM IN ORDER TO PROMOTE LOCAL GOVERNANCE - 9

**WHEREAS** resolution 62-03-21 adopted by the Council of the Maria-Chapdelaine RCM regarding support for the recommendations issued by the Regroupement québécois des médecins for the decentralization of health care

**WHEREAS** the centralization of Quebec's health and social services system, resulting from the 2015 reform sponsored by then Minister Dr. Gaétan Barrette, has deprived the regions of the autonomy necessary to adequately respond to regional needs and priorities.

**WHEREAS** this centralization of powers has led to a disconnection between the decision-making centers and the places where services are provided. and

**WHEREAS** the current administrative burden is an obstacle to the efficient delivery of health and social services in the regions

**WHEREAS** the lack of local governance and management deprives institutions of the autonomy they need to administer care adapted to their clientele, based on their own needs and characteristics.

**WHEREAS** local institutions do not have the budgetary autonomy necessary to manage themselves according to the specific realities of their environment

**WHEREAS** local labour organizations and the various employees wish, through decentralization, to participate and be involved in decisions based on the real needs of health and social services personnel and users.

**WHEREAS** the elected officials of the municipalities in the regions are witnessing the consequences of this centralization

WHEREAS 750 physicians from all regions of Quebec have mobilized under the name "Regroupement québécois des médecins pour la décentralisation des soins de santé" (Quebec group of physicians for the decentralization of health care), who are calling for the decentralization of the health care system.

WHEREAS the said 750 physicians have issued 4 recommendations that are inexpensive, simple and quick to implement, which were transmitted to the Minister of Health and Social Services this summer, namely.The re-establishment of a local decision-making administrator position for each hospital care center.

- The re-establishment of a local Director of Professional Services (DPS) position for each hospital center.

- The re-establishment of a local Council of Physicians, Dentists and Pharmacists (CPDP) for each hospital center. and,

- The re-establishment of a local Chiefs' Table comprised of all department heads within a hospital center.

**WHEREAS** the steps taken by several organizations and actors in this regard are aimed at establishing the foundations of a solid and efficient local governance that will provide access in the region to all basic medical care without any discrimination

**WHEREAS** the management of the current health crisis (COVID-19 pandemic) requires a flexibility and responsiveness that the current decentralized health system lacks

**WHEREAS** all remote regions in Quebec are severely impacted by the centralization of health care and social services

**WHEREAS** the numerous requests and resolutions addressed to the Quebec government and the CISSS de l'Outaouais by the Council of the MRC de La Vallée-de-la-Gatineau since 2015 regarding this centralization of health care and social services in urban areas

WHEREAS despite certain corrections made following the tabling of the "Observation Report on the Centre intégré de santé et de services sociaux de l'Outaouais" by the MSSS representative Mr. Sylvain Gagnon in January 2019, the MRC has not yet received any comments from the MSSS. Sylvain Gagnon in January 2019, many deficiencies and difficulties are still noted.

**WHEREAS** the recommendation of the Planning and Development Committee of the MRC at the meeting held on April 6, 2021, in this file.

THEREFORE, it is.

**APPROVED** by Councilor Joanne Mayer **SUPPORTED** by Councilor Maureen Rice **AND RESOLVED** by the present members of Council, to support resolution 62- 03-21 adopted by the Council of the Maria-Chapdelaine RCM, in support of the 4 recommendations issued by the Regroupement québécois des médecins for the decentralization of health care and in order to request a decentralization of the Quebec health care system in order to favour local governance.
