SUPPORT FOR THE POSITION OF THE QUEBEC FEDERATION OF MUNICIPALITIES - BILL 37 AND LOCAL SUPPLY POLICY - 13

WHEREAS the Government of Quebec recently tabled Bill 37 to dissolve the Center de services partagés du Québec (CSPQ) and the establishment of a Center for Governmental Acquisitions and Technological Infrastructures Quebec;

WHEREAS by this bill, the government plans to consolidate all Quebec government supplies into a single entity, including supplies from the health and social services network;

WHEREAS despite the objective of reducing spending that underpins the creation of this new body, the issue of centralized purchasing is raising many concerns regarding local purchasing, an essential tool for the economic vitality of the regions;

WHEREAS with its bill, the government is betting on volume discounts, without taking into account the impacts for the regions of Quebec;

CONSIDERING the position of the Federation of Quebec Municipalities (FQM) in order to remind the government of the harmful consequences of the concentration of purchasing groups, for small and medium-sized businesses located throughout the region, which will not have the sufficient production capacity to meet the volumes requested and do business with the government;

WHEREAS the FQM believes that the implementation of such a consolidation project cannot be done without the prior adoption of a local supply policy, which would stimulate economic activity in the communities as well as contribute regional development;
