# ADOPTION OF THE BORROWING BY-LAW NUMBER 07-2020- RIRL 2019-935

By-law No. 07-2020 decreeing an expenditure and a loan of \$ 183,314.81 for the repair of the running surface of part of Martindale Road.

**WHEREAS** Council proceeded by public call for tenders in accordance with the provisions of articles 935 and following of the Municipal Code for the repair of the road surface of Martindale road;

**WHEREAS** when the expenses provided for in a loan by-law are subsidized at 50% or more by the government or by one of its departments, the by-law only requires the approval of the Minister of Municipal Affairs and Housing.

**WHEREAS** the lowest bidder following the call for tenders represents an amount of \$ 600 234.13 before applicable taxes;

**WHEREAS** the amount of the non-refundable QST represents a sum of \$ 29,936.68;

**WHEREAS** Council has allocated to the reduction of the loan an amount of \$ 446,856 from the Local Road Assistance Program, Acceleration of investments on the local road network and Restoration of local road infrastructure "AIRRL / RIRL" components the Quebec Ministry of Transport;

WHEREAS the amount payable by taxpayers represents a sum of \$ 183,314.81;

**CONSIDERING THAT** the notice of motion for this by-law was duly given at the municipal council meeting, held on September 21, 2020 and that the draft by-law was submitted at the same time.

THEREFORE, it is

**PROPOSED** by Councilor Luc Thivierge **SUPPORTED** by Councilor Joanne Mayer

#### AND RESOLVED THAT THE COUNCIL DECREES AS FOLLOWS:

#### ARTICLE 1.

The preamble is an integral part of these by-laws.

#### ARTICLE 2.

The council is authorized to carry out road construction work according to the plans and specifications prepared by Mr. Joël Lacroix, engineer of the Municipal Engineering Department of the MRC Vallée-de-la-Gatineau with the number LSM-1710, dated 23 January 2020, including costs, net taxes and contingencies, as it appears from the detailed quote prepared by Excavatech Inc. dated June 11, 2020, which form an integral part of this by-law as appendix "A".

#### ARTICLE 3.

The council is authorized to spend a sum of \$ 183,314.81 for the purposes of this by-law.

#### **ARTICLE 4.**

For the purpose of paying the expenses provided for in this by-law, council is authorized to borrow an amount of \$ 183,314.81, including the 2% discount fee, over a period of 10 years.

#### ARTICLE 5.

To provide for the expenses incurred in relation to the interest and the principal repayment of the annual maturities of the loan, it is by this by-law imposed and it will be deducted, annually, during the term of the loan, from all taxable buildings located on the territory of the municipality, a special tax at a rate sufficient according to their value as it appears on the assessment roll in force each year.

#### ARTICLE 6.

If the amount of an allocation authorized by this by-law is greater than the amount actually spent in relation to this allocation, the council is authorized to use this surplus to pay any other expense decreed by this by-law. and for which the allocation proved insufficient.

### ARTICLE 7.

The council allocates to the reduction of the loan decreed by this by-law any contribution or subsidy that may be paid to it for the payment of part or all of the expenditure decreed by this by-law.

The council also allocates any grant payable over several years to the payment of part or all of the debt service. The repayment term of the loan corresponding to the amount of the grant will be automatically adjusted to the period set for the payment of the grant.

#### **BY-LAW NUMBER 05-2020**

# BY-LAWS CONCERNING PUBLIC SAFETY AND THE MAINTENANCE OF

PRIVATE ROADS

**Whereas there** are several private roads on the territory of the Municipality of Canton de Low;

Whereas the Municipality thus wishes to offer the owners of buildings located on a private road, a public security service;

Whereas the Municipality wishes, however, to establish minimum maintenance conditions for private roads to provide a public security service on this type of road; Whereas a notice of motion and filing of this by-law was duly given at the regular meeting of July 6, 2020;

**PROPOSED** by councilor Luc Thivierge **SUPPORTED** by Councilor Maureen Rice

The council of the Municipality of Canton de Low, by this by-law, orders and rules as follows:

#### **ARTICLE 1**

The preamble to these regulations is an integral part thereof.

#### **ARTICLE 2**

The purpose of this regulation is to determine the minimum conditions for the maintenance and construction of private roads to ensure an efficient response time of the public security service on private roads. The main objectives of this regulation are to:

- 1. Promote informed decision-making, following established rules and procedures
- 2. Avoid any ambiguity about providing a public security service on private roads

# ARTICLE 3 – ROADS TARGETED

The Municipality provides a public security service on private roads provided that the maintenance, of the said private road, meets the following criteria:

- 1. Have a gravel running surface with a width of at least 6 meters
- 2. Be clear of all obstructions over a width of 8 meters.
- 3. Be clear of all obstructions to a height of 5 meters.
- 4. In the case of a cul-de-sac, have a roundabout large and wide enough to allow the turn of a truck with its equipment or, a place to be able to make a turn in three
- (3) points. (T). In this case, if the three (3) point turn is made on land or private entrances, the municipality disclaims all responsibility for any damage incurred.
- 5. The running surface must be gravel at least offering good compaction.
- 6. In winter, the path must be clear (minimum of 4 meters) and the abrasive must be spread in sufficient quantity.

In the event that the running surface is not gravel or that no abrasive is spread in winter, the fire safety service reserves the right to a non-intervention. This is in order to protect its equipment and the health and safety of its emergency responders.

#### ARTICLE 4 - RESPONSIBILITIES OF THE OWNER

At all times, the owners remain responsible for the maintenance of their driveways and culverts, even if it was installed by the Municipality. The owners are also responsible for the maintenance of the Private roads.

The municipality disclaims any liability caused by its equipment to all private roads or entrance doors.

# ARTICLE 5 - DIMENSIONS AND COMPACTION

1. The driveway to a residential property must have a minimum width of six meters (6 m) and must have a compaction capable of supporting the weight of heavy vehicles.

2. The culvert must have a minimum diameter of 450 (mm).

### **ARTICLE 6 - DECISION OF THE MUNICIPALITY**

After receiving a recommendation from the management of the fire department, the municipal inspector or the foreman of public works, the council accepts, with or without conditions, to send a warning for private roads that will not be maintained. adequately informing as well as the intervention deadlines could not be respected.

#### ARTICLE 7 - NON-RESPONSIBILITIES OF THE MUNICIPALITY

Under no circumstances can the Municipality be held responsible for any damage caused directly or indirectly by the Municipality's public security equipment or employees.

#### **ARTICLE 8 - REPEAL**

This by-law replaces and repeals all by-laws, policies and procedures relating to public safety on private roads.

#### **ARTICLE 9 - INTERPRETATION**

The masculine is used in these regulations without discrimination and includes the feminine in order to avoid a too heavy text.

The French version of these rules prevails over the English version as regards its interpretation.

### **ARTICLE 10 - ENTRY INTO FORCE**

These regulations will come into force in accordance with the law.
