#### **LOCAL EMERGENCY STATEMENT (RENEWAL) - 4**

**WHEREAS** due to loss of parts of roads due to major floods that require, among other things, the voluntary evacuation of part of the population;

WHEREAS on April 23<sup>rd</sup>, 2019, the Municipal Council met at a special assembly to declare the state of emergency for a period of 5 days by its resolution No. 092-04-2019;

WHEREAS the first paragraph of section 43 of the Civil Protection Act (CQLR 2.3) provides that the state of emergency declared by the municipal council may be renewed for periods of up to five days, authorization of the Minister of Public Security;

WHEREAS the municipality has informed the Minister that it must take immediate action to protect the life, health or integrity of persons, whom it considers it cannot achieve within the framework of its usual operating rules or the framework of an applicable civil security plan;

WHEREAS it is expedient to renew the declaration of state of emergency throughout the territory of the municipality for a period of five days due to the snow melt, the incessant rain and semi-open municipal roads during first five days in a state of local emergency;

#### FOR THESE REASONS, it is

**PROPOSED** by Councilor Ghyslain Robert, **SUPPORTED** by Councilor Joanne Mayer

**BE IT RESOLVED**, by council of the Municipality Township of Low, in a extraordinary meeting on April 28, 2019 at 9:45 am in the Municipal Library, located at 4A, Chemin d'Amour, Township of Low:

- 1. Renew the declaration of state of emergency made by the resolution n ° 092-04-2019 of April 23, 2019 throughout the territory of the municipality for an additional period of 4 days, ending May 1<sup>st</sup> at 2:30PM and under reservation of the authorization of the Minister of Public Security;
- 2. Designate Mr. Pierre Gagnon, Director General responsible for civil security in the territory so that he is empowered to exercise the following powers:
  - (1) control access to the traffic lanes or the territory concerned or subject them to special rules;
  - (2) grant, for the time it deems necessary for the rapid and efficient execution of the intervention measures, authorizations or derogations in the areas that fall within the jurisdiction of the municipality;
  - (3) order, where there is no other means of protection, the evacuation of persons from all or part of the territory concerned that it determines or, on the advice of the authority responsible for the protection of health public, their confinement and, if they have no other resources, to ensure their accommodation, food and clothing and their safety;
  - (4) to request the assistance of any citizen able to assist the deployed personnel;
  - (5) to requisition in its territory the necessary means of assistance and private accommodation other than those required for the implementation of a civil security plan adopted under this Chapter or Chapter VI;

(6) to make the expenses and to conclude the contracts that it deems necessary.

THAT this declaration comes into force on April 28, 2019, at 09:50 am;

**THAT** the municipality, the council members and the persons authorized to act by virtue of the declaration cannot be prosecuted for an act done in good faith in the exercise of these powers.
