Mayor's Report on the Highlights of the 2022 Financial Report

Pursuant to Section 176.2.2 of the Municipal Code, at this regular meeting of municipal Council on July 3, 2023, I report to the Lowites the highlights of the financial report.

RESULTS AS OF DECEMBER 31, 2022

The financial statements have been audited by the firm of Daniel Tétreault - CPA, Auditor CA who have confirmed that they give a true and fair view of the financial position of the Municipality for the year ended December 31, 2022, and adequately reflect the results of its operations, changes in net assets, net debt and cash flows for the year then ended, in accordance with Canadian Public Sector Accounting Standards. The 2022 financial report was tabled with the municipal Council on July 3, 2023, along with full reports from the external auditor.

During the year 2022, revenues from the Municipality's financial activities totalled \$3,098,382 and net expenditures totalled \$2,876,364. The Municipality thus closed the year 2022 with a surplus of \$179,172, which is explained by the collection of various unbudgeted additional revenues and the reduction of certain expenses.
