FACTSHEET: Property assessments, 2023 budget and taxation

Property assessments

On October 31, 2022, the MRC de la Vallée-de-la-Gatineau filed the property assessment roll for the years 2023-2024-2025 for five of its seventeen municipalities as well as for the unorganized territories (TNO), including the Township of Low.

In Low, the average increase in assessment units is 36.3%: vacant land value has increased on average by 18% and residential properties have increased on average by 39.9%. The median value is now \$176,100. To request a review of your assessment, the deadline is April 30, 2023. Contact the MRC at 819-463-3241 ext. 250.

2023 budget

Corrections in presentation of one-time grants and projects and allocations and reserved funds, have been made.

Increased costs including fuel, labor, training and insurance have significantly affected the administration, fire department, public works and waste management budgets.

The municipality has managed to reduce the expenses under its control by limiting the increase in these expenses to 1.6%. Some fees, including contributions to the MRC expenses, transit, the airport and policing, are collected and distributed by the Municipality, but outside its control. With these increases, the overall budget is up by 13.93%.

The three-year capital plan presents a list of projects that the municipality would like to carry out in the next few years, depending on the availability of funds and financial assistance. If and when these projects advance, a resolution with details would be brought to Council before any spending is committed.

Taxation

Increases in assessed property values, an increase in operating costs for the municipality, and higher contributions collected for shared services have in turn led to a higher tax bill for most property owners in Low.

- Despite overall higher expenses, the municipality has decreased its tax rate by almost 34% from \$0.8541/\$100 of assessment to \$0.5655/\$100 of assessment.
- The waste collection rate has been increased by \$205 per residence to cover the higher costs of the
 new contract. Covering increased costs for labor and fuel, the new contract also adds the mandated
 collection of compost. Organic collection works out to about \$77.74 per household per year. The less
 waste we send to landfill by composting and recycling, the more subsidies we are entitled to receive
 from RECYC Quebec. The environment committee will continue to monitor usage and explore ways to
 manage waste collection.
- A new fee structure for police and fire services offsets the increase in taxes against the increase in assessments.

Different properties are seeing different changes on their tax bills.

- For a property with no increase in assessed value, the tax bill has decreased.
- For properties below the average of 39.6%, the increase is mainly related to the rate for waste management.
- For a property with an above-average increase, there is an increase in the tax bill.

Here are a few examples:

Property assessed at \$176,100 with no change in value.

Tax bill in 2022: \$1,835 Tax bill in 2023: \$1,764 Difference: -\$71

Property reassessed from \$150,000 to \$185,000 (23% increase)

Tax bill in 2022: \$1,613 Tax bill in 2023: \$1,815 Difference: \$202

Property reassessed from \$200,000 to \$275,000 (38% increase)

Tax bill in 2022: \$2,040 Tax bill in 2023: \$2,324 Difference: \$284

Property reassessed from \$300,000 to \$500,000 (67% increase)

Tax bill in 2022: \$2,894 Tax bill in 2023: \$3,597 Difference: \$703
