2025-04-076 TO ADOPT THE MUNICIPAL CIVIL PROTECTION PLAN - MARCH 2025 REVISION

WHEREAS the Municipality of the Township of Low adopted, at a regular meeting of its Municipal Council held on May 9, 2005, resolution number 139-06-2005, for the purpose of accepting the Municipal Civil Protection Plan (Emergency Measures Plan);

WHEREAS section 7 of the Civil Protection Act, aimed at promoting disaster resilience, stipulates that each local municipality must set up a civil protection coordination structure responsible for managing disaster risks and coordinating disaster response on its territory, under the authority of a municipal civil protection coordinator designated by the municipality, and that it must also establish and keep up to date a civil protection plan that includes general preparedness measures to respond to a disaster or imminent disaster, including procedures for alerting the population and mobilizing resources;

WHEREAS, in order to ensure the protection of people and property in the event of a disaster on its territory, the Municipality of the Township of Low has prepared a civil protection plan, in accordance with the model proposed by the Ministry of Public Security (MPS);

2025-04-076 WHEREAS the objectives of this plan are:

- 1. to identify the potential hazards to which the Municipality is exposed, as well as the populations and assets most vulnerable to these hazards on the territory;
- 2. to put in place measures enabling the Municipality to respond promptly to any type of disaster;
- 3. to provide for the use of additional resources during disasters by establishing agreements with other municipalities or organizations in order to increase the Municipality's response capacity;
- 4. provide for cooperation with various organizations that may be involved in disaster management.

2025-04-077 TO AUTHORIZE SIGNATURE - MUTUAL AID AGREEMENT - CIVIL SECURITY PLAN WITH THE MUNICIPALITY OF DENHOLM

WHEREAS local and regional municipalities, as well as urban agglomerations, play a key role in strengthening society's resilience to disasters, as they assume a number of civil protection responsibilities, including coordinating and planning all civil protection efforts on their territory and at the time of and following disasters, deploying resources to provide assistance to affected populations, and managing the situation with a view to recovery as quickly and effectively as possible;

WHEREAS the municipality of the township of Low adopted its Civil Protection Plan at a regular council meeting held on April 7 2025;

WHEREAS the municipality of Denholm adopted its Civil Protection Plan at a regular council meeting held on February 4^{th} , 2025;

WHEREAS Article 7 of the Regulations on alert and mobilization procedures and minimum rescue resources to protect the safety of people and property in the event of a disaster stipulates that a local municipality must designate locations that can, in the event of a real or imminent disaster, Section 8 of the same by-law stipulates that a coordination center must have telecommunications and computer equipment enabling the reception, processing and transmission of disaster management information, and the space required to accommodate the persons designated by the municipality. In addition, the municipality must be able to cope with a power failure at the coordination center;

2025-04-077 WHEREAS Article 9 of the above-mentioned by-law also stipulates that service and temporary accommodation centers for victims must be equipped with sanitary facilities. In addition, the municipality must be in a position to deal with any interruption in the power supply to these centers;

WHEREAS the municipality of the township of Low adopted, at an extraordinary meeting of its Municipal Council held on December 18, 2024, its three-year capital expenditure program including the purchase, during the year 2025, of two generators to prepare its emergency measures coordination center and its disaster services center for a possible interruption in the power supply and that the call for tenders to this effect is being prepared;

WHEREAS centers of the municipality of Denholm are equipped with generators and that the said municipality agrees to lend its premises in the event of deployment of the Civil security plan to the municipality of the township of Low;

WHEREAS the parties also agree to assist each other with the various resources that may be required in the event of an emergency, whether in terms of material or human resources;

WHEREAS Section 16 of the Civil Protection Act, designed to promote disaster resilience, stipulates that a local municipality that, when the situation exceeds its response capabilities or those of the resources it has secured by agreement, requests the assistance of another municipal authority to respond to a disaster that occurs or is imminent on its territory, must assume the cost of this assistance;

WHEREAS the PARTIES to the agreement wish to prevail themselves of article 569 of the Municipal Code of Québec (RRLRQ, chapter C-27.1) to enter into an agreement to agree among themselves on the terms and conditions for intermunicipal mutual aid in matters of civil security on their respective territories;

WHEREAS certain access codes will have to be created for the mission leaders of both PARTIES involved in mutual assistance operations;

WHEREAS the aforementioned mission leaders may have access to confidential information in the context of such mutual assistance;

WHEREAS the Act Respecting Access to Information Held by Public Bodies and the Protection of Personal Information sets out restrictions on access rights in Section 2 of Chapter 2, and stipulates provisions for the protection of personal information in Chapter 3.

WHEREAS the Revised Land Use and Development Plan (SAD) of the MRC de la Vallée-de-la-Gatineau came into force on November 15, 2021, i.e. the day of notification by the Minister of Municipal Affairs and Habitation du Québec, to the effect that this document respects government guidelines in terms of land use planning;

2025-04-079 WHEREAS in accordance with the provisions of section 59 of the Land Use Planning and Development Act, the local municipalities of the regional county municipality have a period of two years, following the coming into force of the SAD, to adopt a new urban planning plan as well as new concordant urban planning regulations;

WHEREAS the Municipality of the township of Low adopted, during a regular meeting of its Municipal Council, held on November 6, 2023, the resolution bearing number 2023-174, for the purpose of requesting an extension of deadline from the Ministère des Affaires municipals et de l'Habitation (MAMH) for the overhaul of the Urban Planning Plan and regulations and that the said ministry has granted a deadline of March 1, 2024;

WHEREAS the Municipality of the township of Low adopted, during a regular meeting of its Municipal Council, held on April 2, 2024, the resolution bearing number 2024-056, for the purpose of requesting an extension of deadline from the Ministère des Affaires municipals et de l'Habitation (MAMH) for the overhaul of the Urban Planning Plan and regulations and that the said ministry has granted a deadline of November 5, 2024;

WHEREAS the position of Municipal Inspector became vacant on May 25, 2024, and that the position of Deputy Director General became vacant on June 9, 2024, causing a significant overload for the Director General and Clerk-Treasurer, who remained the only municipal official involved in the process of revising the Urban Plan and Bylaws, and delaying the process of revising said bylaws;

WHEREAS the revision of these by-laws has nevertheless progressed during this period, and all that remains to be done is to make the modifications requested by the Planning Committee before presenting the whole to the members of the Municipal Council to begin the process that will lead to the adoption of the Municipality of the Township of Low's Urban Plan and Bylaws;

WHEREAS the position of Municipal Inspector was filled on September 17, 2024;

WHEREAS the Municipality of the township of Low adopted, during a regular meeting of its Municipal Council, held on November 4, 2024, the resolution bearing number 2024-177, for the purpose of requesting an extension of deadline from the Ministère des Affaires municipales et de l'Habitation (MAMH) for the overhaul of the Urban Planning Plan and regulations and that the said ministry has granted a deadline of May 5, 2025;

WHEREAS the Municipality of the township of Low will not be able to complete the revision of its urban planning plan and regulations before May 5, 2025, and therefore, it is asking the MAMH to obtain additional time.

(FQM) - ABOLITION OF THE
RÉNORÉGION PROGRAM - REQUEST
TO THE QUEBEC GOVERNMENT TO
URGENTLY RECONSIDER ITS
DECISION

WHEREAS the Société d'habitation du Québec (SHQ) confirmed two days after the reading of the Quebec government's 2025-2026 budget that it was abandoning the RénoRégion program, an essential program to help the less well-off homeowners in our communities, often seniors or single-parent families living in rural areas, to correct major defects in their modest residences;

WHEREAS this program has made it possible to keep several thousand people in their homes, in areas where the housing crisis is also raging, and where there is no affordable housing, or even less low-cost housing;

WHEREAS there are more than a thousand families on waiting lists in Quebec's MRCs;

WHEREAS, on March 27, the Fédération québécoise des municipalités (FQM) asked Quebec Premier François Legault to show concern for our most vulnerable citizens and families by urgently remedying the situation;

WHEREAS this request has gone unanswered, and that the 24 and 36 unit modular apartment projects in a number of Quebec cities since promoted by the Minister responsible for Housing, Mme France-Élaine Duranceau, cannot meet the needs of the regions;

WHEREAS, although the RénoRégion program has cost the Quebec government less than \$18 million per year and represents only 0.0001% of overall spending, the Minister justifies this choice for reasons of sound management of public finances;

WHEREAS the program's average subsidy is \$19,309, a fraction of the actual construction costs of the new housing units promoted by the Minister;

WHEREAS last year, at the request of the SHQ, the FQM submitted a series of proposals to increase the program's efficiency and make it more accessible to better meet needs across Quebec;

WHEREAS the SHQ was to launch an improved version of the RénoRégion program following its consultations in 2025;

WHEREAS the abolition of this program is detrimental to the most vulnerable members of our communities.

PROPOSED AND SUPPORTED UNANIMOUS

FOR THESE REASONS, this Council:

- 1. States that the preamble is an integral part of this resolution.
- 2. Supports the Fédération québécoise des municipalités (FQM) in its efforts to ask the Premier of Québec, François Legault, and his Minister responsible for Housing, France-Élaine Duranceau, to immediately relaunch the RénoRégion program for the 2025-2026 fiscal year, and to commit to its long-term financing, and to complete the process of improving the program to ensure greater accessibility in all regions of Québec.
- 3.
