WHEREAS the MRC de la Vallée-de-la-Gatineau (MRCVG) adopted at their regular meeting of April 15, 2025, bearing resolution number 2025-R-AG150, by-law SQ 2021-005 (R.M. 2025-411 "By-law concerning the declaration of jurisdiction of the MRC de la Vallée-de-la-Gatineau with respect to a portion of the safety jurisdiction concerning animal management and control for all of its municipalities" and effective since April 23, 2025, conferring on the MRCVG the power to adopt any by-law relating to animal control;

WHEREAS the MRCVG delegates to the SPCA de l'Outaouais the power to intervene within the framework of the present by-law and to see to its application, as long as the Agreement with the Society is in force;

WHEREAS the existing by-laws concerning animals should be repealed in view of the MRCVG's new jurisdiction;

WHEREAS in accordance with article 454 of the Quebec Municipal Code, a by-law may only be repealed by another by-law;

THEREFORE, IT IS, it is ordained and decreed by the Municipal Council of the Municipality of the Township of Low and the said Council hereby ordains and decrees as follows, namely:

ARTICLE 1 - PREAMBULE

WHEREAS paragraph 4 of the first paragraph of section 626 of the Highway Safety Code (R. S.Q., c. C-24.2) allows a municipality to set by by-law the minimum or maximum speed of road vehicles in its territory;

WHEREAS the municipal council deems it appropriate to regulate the speed limits on the road network of the territory of the Municipality of the Township of Low;

WHEREAS the presence of a secondary school on Chemin Principal;

WHEREAS the urbanization perimeter includes part of Martindale and Fieldville roads;

WHEREAS the safety of schoolchildren and residents within the urbanization perimeter;

WHEREAS Fieldville Road is non-linear and several residential entrances / exits are found before or after curves;

WHEREAS the notice of motion was given by Councilor Ghyslain Robert at a council meeting held on June 2, 2025, and the bill was tabled at a council meeting held on July 7, 2025, to repeal and replace by-law 05-2021 concerning the speed limit on Brooks, Principal, Farm, Paugan Martindale, and Fieldville roads;

WHEREAS the Municipality of the Township of Low undertakes to communicate the speed changes be posting the changes on our website and our bulletin boards;

WHEREAS traffic signs will be posted at the start of each speed reduction section;

THEREFORE, it is ordained and decreed by the Municipal Council of the Municipality of the Township of Low and the said Council ordains and decrees by the present by-law as follows, namely:

ARTICLE 1 - PREAMBULE

The preamble to the present by-law forms an integral part thereof.

ARTICLE 2 - OBJECTIVE AND APPLICATION

No one may drive a road vehicle at a speed:

- a) Exceeding 40 km / h on Brooks Road;
- b) Exceeding 40 km / h on Chemin Principal except for the school zone in front of St-Michael's school which remains at 30 km / h;
- c) Exceeding 40 km / h on Farm Road;
- d) Exceeding 40 km / h on Paugan Road;
- e) Exceeding 40 km / h on Martindale Road from route 105 to 152 Martindale Road,
- f) Exceeding 40 km / h on Chemin Fieldville from Route 105 to Chemin du Ruisseau (within the urbanization perimeter);
- g) Exceeding 40 km / h on Donovan road

ARTICLE 3 - INSTALLATION

Appropriate signage will be installed by the Municipality of Low.

ARTICLE 4 - INFRACTIONS AND PENALTIES

Anyone who contravenes section 2 of this by-law commits an offense and is liable to a fine provided for in section 516 or 516.1 of the Highway Safety Code.

ARTICLE 5 - REPEAL OF REGULATIONS

This regulation repeals, for all legal purposes, any regulation and management policy prior to the adoption of this regulation or any provisions of any regulation or policy that are inconsistent with those enacted above.
