In accordance with Article 445 of the Quebec Municipal Code, the Mayor informs citizens that the purpose of this by-law is to:

- a) Establish a code of ethics and professional conduct for all members of the Township of Low Council.
- b) Give priority to the values that guide the decisions of an elected member of the Municipal Council.
- c) To contribute to a better understanding of the values of the municipality.  
To subscribe to values that emphasize integrity, honor in the performance of council duties, and prudence in the pursuit of the public interest in order to prevent ethical conflicts and, if they arise, to help resolve them effectively and judiciously.
- d) Ensure the application of control measures for ethical breaches, including, but not limited to: integrity, respect and civility, loyalty, fairness, honesty, objectivity, impartiality, and sound management in the public interest to govern the Municipality of Low.
- e) Establish standards of conduct that promote the integration of these values into the decision-making process of elected officials and, in general, into their conduct.

Council members must perform their duties and conduct their personal affairs in a manner that preserves and maintains public confidence in the integrity, objectivity, and impartiality of the decisions of the Municipality of the Township of Low. Members of the municipal council must also act with integrity, objectivity, and impartiality, but must also preserve appearances and promote transparency by behaving in a manner that preserves and maintains public confidence in the integrity, objectivity, and impartiality of the municipal enterprise.
