**2026-02-038 TO SUPPORT THE CITY OF GRACEFIELD -
OPPOSITION TO PARTICIPATION IN THE FEDERAL
ASSAULT-STYLE FIREARMS BUYBACK PROGRAM**

WHEREAS on January 17, 2026, the Government of Canada launched the federal assault-style firearm buyback program;

WHEREAS Canadians have from January 19 to March 31, 2026, to participate in the program, which provides for the voluntary surrender of their prohibited weapons in exchange for compensation;

WHEREAS the financial compensation provided for under the buyback program is considered insufficient, unfair, or unguaranteed for all affected owners;

WHEREAS the weapons covered by the ban are modern civilian hunting or sporting firearms, not military assault weapons, and that they are neither used nor required by the Canadian Armed Forces to defend the country;

WHEREAS in Quebec, the Sûreté du Québec will coordinate the operation;

WHEREAS police resources are already limited and that their mobilization for the enforcement of this regime diverts personnel essential to the fight against real crime;

WHEREAS trust between the public and police forces is a fundamental pillar of public safety;

WHEREAS the coercive enforcement of this prohibition risks undermining this relationship of trust and exacerbating social tensions;

WHEREAS public safety is a responsibility shared between the federal, provincial, and municipal governments, as well as police forces;

WHEREAS municipalities are local governments directly responsible for the well-being, social cohesion, and safety of their populations;

WHEREAS legal firearm owners are already subject to strict licensing, training, registration, background checks, secure storage, and compliance with laws;

WHEREAS available data show that the weapons used in violent crimes come mainly from the black market and not from the legal market;

WHEREAS public safety priorities should focus on combating illegal arms trafficking, criminal groups, and smuggling;

WHEREAS the prohibition and mandatory buyback of firearms mainly target law-abiding citizens, with no significant direct impact on crime;

WHEREAS the imposition of this regime represents an infringement on the legitimate property rights of these citizens;

WHEREAS this regime does not take into account the territorial, social, economic, and cultural realities specific to municipalities;

WHEREAS many rural, agricultural, and northern communities use firearms legitimately for hunting, subsistence, livestock protection, and personal safety in isolated areas;

2026-02-037 WHEREAS several Canadian provinces have publicly expressed their opposition to this prohibition and buyback regime, refusing to cooperate with or enforce it because of its ineffectiveness, cost, and unfairness;

WHEREAS municipalities have no real power in the development of this policy, but are directly impacted by it

FOR THESE REASONS, this Council:

1. States that the preamble is an integral part of this resolution.
2. Supports the City of Gracefield in its opposition to participating in the federal program to buy back assault-style firearms.
3. Officially requests that the federal government end its program to buy back assault-style firearms.
4. Officially requests that the Sûreté du Québec, in the event that this program is not repealed, not enforce the federal government's measures prohibiting and mandating the buyback of firearms within its jurisdiction.
5. Affirms that the priority in public safety must be the fight against illegal arms trafficking, organized crime, and actual gun violence, rather than the confiscation of legally owned firearms.
6. Calls on the Government of Quebec to intervene with the federal government to review the current approach and give priority to policies based on evidence and real effectiveness in public safety.
7. Affirms its support for law-abiding citizens, hunters, farmers, rural communities, and legitimate users of firearms.
8. Transmits a copy of this resolution to the Sûreté du Québec, the Quebec Minister of Public Security, the Premier of Quebec, the federal Minister of Public Safety, the relevant provincial and federal members of parliament, the Fédération québécoise des municipalités (FQM), the Union des municipalités du Québec (UMQ), the MRC de la Vallée-de-la-Gatineau, and the municipalities and cities of Quebec for their support.
9. Authorizes, hereby, Mr. Mayor Patrick Beaudry and/or the Director General and Clerk-Treasurer, Mrs. Myrian Nadon, or their replacements, to sign, for and on behalf of the Municipality of the Township of Low, all documents giving effect to this resolution.
