WHEREAS the Municipality adopted Resolution bearing number. 2023-031 at a regular meeting of its Municipal Council held on February 6, 2023 for the purpose to commit financially to the project of the Village des aînés de la Vallée de la Gatineau;

WHEREAS on March 31, 2026, a representative of the Village des aînés de la Vallée de la Gatineau made a presentation to the Municipal Council outlining new parameters that substantially modify the terms of the original agreement without providing financial statements;

WHEREAS these modifications were proposed unilaterally, without prior consultation or the consent of the Municipal Council;

WHEREAS such changes render the original agreement null and void and of no further effect;

WHEREAS the Municipal Council places paramount importance on respecting the principles of good governance, transparency, and mutual consent in all its partnerships and financial commitments;

WHEREAS the Municipal Council has the responsibility to ensure prudent, responsible, and transparent management of public funds;

WHEREAS the Village des aînés de la Vallée de la Gatineau project aims to provide housing adapted to the needs of seniors in the region, an initiative that the Municipal Council continues to support;

2026-04-065 WHEREAS the Municipal Council remains open to all partnership proposals as long as they respect municipal priorities, budgetary constraints, and the rules of good governance;

WHEREAS the Municipal Council considers it appropriate to repeal the resolution and withdraw its support for the project.
