WORKING CAPITAL FUND – LEASE TO  
OWN PORTABLE RADIOS FOR THE FIRE  
DEPARTMENT – DECREE AN EXPENSE  
OF AN AMOUNT OF \$22,372.67  
“TAXES INCLUDED”**

WHEREAS the Fire Safety Department must replace twelve portable radios;

WHEREAS the Public Security Committee recommended, at its meeting held on April 28, 2026, in its recommendation numbered SP-26-04-002 that the members of the Municipal Council proceed with the acquisition of the said portable radios;

WHEREAS the Municipal Council considers it appropriate to authorize the Fire Safety Department to carry out the project for the acquisition and replacement of the twelve portable radios, which requires a loan from the “net taxes” working capital fund to finance it, and that the repayment terms will be spread over 3 years;

FOR THESE REASONS, this Council:

1. States that the preamble is an integral part of this resolution.
2. Authorizes, on the recommendation of the Public Security committee and the approval of the office of the Director General, a loan of \$22,372.67 from the working capital to finance the purchase of the twelve portable radios.
3. Mention that the said sum borrowed shall be repaid to the working capital in equal annual instalments at the end of 3 years.
4. Authorizes, hereby, Mr. Mayor Patrick Beaudry and/or the Director General and Clerk-Treasurer, Mrs, Myrian Nadon, or their replacements, to sign, for and on behalf of the Municipality of the Township of Low, all documents giving effect to this resolution.
